

COVID 19 infections are increasing again and we have reached the 96% of the peak of the highest daily rate on April 15. (Reuters, 2022).

The country has 450 infections to date of the delta variant that is seen to be driving a surge across Southeast Asia. (Philstar Global, 9<sup>th</sup> Aug. 2021)

- **D.** Fear of the adverse effect of COVID 19 vaccine
- C. Downgraded quality health care services due to lack of physical consultation and treatment hubs have just started "Telehealth" practice

#### Prices of COVID 19 Vaccine:


The Government estimates that it will spend an average composite cost of around PHP 1,300.00 per person for the vaccination program. This includes vaccine cost (assuming a two-dose requirement) and ancillaries. (DOH, 2021).

As of August 8, 2021, over 13 million people received the first of two doses of the COVID-19 vaccine in the Philippines. In contrast, roughly 11.4 million have been fully vaccinated from the virus.

COVID-19 vaccination in the Philippines started in March 2021 and the country aims to vaccinate 58 million people by the end of the year

Priority population groups for vaccination:

A1: Frontline workers in health facilities both national and local, private and public, health professionals and non-professionals like students, nursing aides, janitors, barangay health workers, etc.

A2: Senior citizens aged 60 years old and above

A3: Persons with comorbidities

A4: Frontline personnel in essential sectors including uniformed personnel and those in working sectors identified by the IATF as essential during ECQ

A5: Indigent population

B1: Teachers, social workers

B2: Other government workers

B3: Other essential workers

B4: Socio-demographic groups at significantly

higher risk other than senior citizens and

indigenous people

B5: Overseas Filipino workers

B6: Other remaining workforce

PLHIV and LGBTQ may register for COVID 19 vaccine based on these classifications where they may fit

#### **Barriers for PLHIV and Key Populations in accessing C-19 vaccines:**

Lack of clear policies specific for PLHIV

Clearance before vaccination (CD4 count, VL, consultation with the doctor from the facility)

Lack of clear information

Ways to access to C-19 vaccine, effects of C-19 vaccine to PLHIV and its possible adverse effects

Transportation expenses in going to vaccination sites

# a. Specific issue you wish to highlight relating to C-19 vaccine information and access:

- Confidentiality: PLHIV at the vaccination site (the fear of being disclosed)
- The need for a standard requirements for the PLHIV's vaccination

(for example: Is it required to have a high CD4 result and a low VL result before they can have access to the vaccine?)

- Most of the facilities don't have regular physician schedule to provide them the medical clearance that they need.
- Most PLHIV's are registering in LGU as A4 category especially those who will be accessing the vaccine from their work in fear of getting disclosed.

#### b. Needs to be done:

- COVID 19 vaccination for PLHIV at the treatment hub instead of going to the regular vaccination site
- Standard requirement for PLHIV for vaccination

#### c. Current Efforts of the Pinoy Plus:

- Continued operation of PLHIV Response Center
- Creation of posters promoting COVID 19 vaccine for the PLHIV
