CURRENT CASE


- Spiked significantly since the beginning of July
- Decrease gradually in the last 10 days
- But instead, it went increased on outside of Java and Bali island or in remote islands and area



- Access to Health Services (health resources being redirected to C-19, KAP reluctant to visit services, etc)
- Economy (loss of income, unemployment, etc)
- Psychological impact (GBV/IPV increase, confinement, lack of social interaction, anxiety of the virus infection)

MONTHLY CONFIRMED CASE





WHO IS BEING LEFT BEHIND?

- HIV still considered as co-morbid and are requires VL & CD4 test result
- Marginalized, those who do not have ID Card in particular

ELIGIBILITY

All citizens above 12 years are eligible for vaccine including pregnant women, except for those with serious health conditions, allergy, blood pressure, etc.

KEY BARRIERS TO C-19 ACCESS FOR PLHIV & KAP

- · ID card ownership
- Geographical with transportation issue
- Disbelief to vaccine efficacy and fear of side effect
- Worry for the co-morbid*



ID Card Ownership vs Vaccination

Many of HIV KAP, Transwomen in particular, are struggling with the ID Card ownership which hinder their way to vaccine access and government social support.

Distribution of Information

- Misguided by hoax and unreliable source of information, many believe on the ineffectiveness of vaccine, halal status, and even the fatal side effects.
 - Health service providers that are not yet updated with the most recent information
 - Updated regulation on the data and documents requirement for vaccination did not reach the rural areas



IAC EFFORTS

- Advocacy by IAC together with SuaraKita to Home Ministry's Population and Civil Registration and resulted more then 80 Transwomen gets ID Card
- Assisting 32 Transwomen without ID Card to vaccination center
- Publishing campaign materials on website and social media containing the facts and information on COVID19, Vaccination, and its correlation with HIV. Further socialization are also planned
- Encourage and involve in the TRIPS Waiver Proposal
- Encourage vaccination centre expansion, particularly for KAP



RECOMMENDATION

- Differentiated Vaccination Model (facility-based, static, mobile)
- Encourage local production for Vaccine (Indonesia needs mRNA Vaccine Technology)
- Friendlier registration process, including breaking ID card barriers
- Expand and scale up the widespread of information including updates on regulation and requirements
- Follow and monitor the progress of TRIPS Waiver
- Strengthen and expand campaign on Vaccine, collaboration with influencers, religious leaders, public leaders, etc.
- Indonesia starts rolling out booster vaccine for health workers
